Consultation on the SEMLEP European Social Fund Programme 2017-2020

Introduction

The European Social Fund (ESF) to date has invested around £30 million in employment, skills and social inclusion projects across the historical SEMLEP and NEP areas which will come to an end between 2019 and 2020 (see annex 1).

We are now planning for the remainder of the ESF Programme which will cover the enlarged SEMLEP area following the merger with NEP.

In doing so, we assume that the United Kingdom will officially leave the European Union (EU) in Spring 2019, possibly shortening the time available to commit the remaining $\pm 22 \text{m}^{1}$ of ESF. New projects will only be guaranteed funding from the ESF if a funding agreement is in place <u>before</u> the UK leaves the EU, therefore the timetable for funding applications should start no later than Autumn 2017.

There are several unknowns affecting the ESF Programme not least the future of match funding from Opt-in organisations, whether LEPs will be allowed to commit 100% of funds and make virements between the key Investment Priorities (unemployment, skills and social inclusion) to reflect changes in the local labour market and the economy.

Irrespectively we are keen to hear views from stakeholders as to the future of the second half of the ESF Programme, as we are acutely aware there is a degree of duplication between current ESF projects, and with other statutory provision.

The purpose of the stakeholder consultation is to seek views on the key issues not addressed by the SEMLEP ESF Programme² so far, so that any future activity is targeted where most need it. SEMLEP is also undertaking an ESF Data Refresh which will underpin future calls alongside the ESIF Strategies and an updated Implementation Plan.

At the same time the Department for Work and Pensions, the Managing Authority for the ESF Programme, will be undertaking a review of the ESF Operational Programme³ and is consulting stakeholders on changes that may be needed to reflect differences in the labour market, the economy and national policy (like for instance the introduction of the Universal Credit) from when the Operational Programme was first written. The aim of the consultation exercise is to review what is required in the 2nd half of the programme working within the current OP requirements.
